Jonathan's Story, Education "I'm living proof that when you step into someone's life and show them they have value, it will take them far."

No one in Johnathan's immediate family had graduated from high school; he dropped out in 9th grade to work to support the family. At the time, they were living in a motel after being evicted from their home. Something changed when Johnathan started working with the United Way team at Benjamin Franklin High School, the home base for our Neighborhood Zone in Brooklyn. Johnathan received academic and emotional support from caring staff who believed in his innate strengths and abilities and helped him believe in himself, too. Today, Johnathan is a proud Coppin State University graduate and is now an accomplished leasing agent for Seawall, a leading local real estate company.

Sam's Story, Housing

For so many, just one emergency can upend their lives. Sam lives in a Baltimore City apartment with his two daughters, who are three- and 12-years old. He was working for FedEx, but things slowed down and when his father was injured, Sam had to take care of him. It was getting harder to keep up with the mounting bills. One day his older daughter called to tell him an eviction notice was on their front door.

His family helped all they could. He took out a bank loan. He called agencies for housing assistance but was transferred to another agency or referred to a shelter. He felt like he had exhausted all his options and had many sleepless nights feeling hopeless. Finally, he contacted a United Way housing team member, who quickly contacted the landlord. She informed them that United Way could help cover what Sam owed and provided a letter of intent to pay, which halted the eviction. The 211 information specialist secured emergency food and shelter for Sam through our 211 Emergency Assistance Program. Sam received assistance to cover three months of rent and was connected with help to cover his utility bill. He can sleep easier thanks to United Way, and his family is secure in their home.

Simone's Story, Childcare

Simone wanted to return to work after she had her baby but could not find affordable childcare and was forced to take extended leave from her job. She learned about United Way's Family Center in Columbia through Social Services and decided to for her child in the program.

"The Director of the Family Center recommended I submit some scholarship requests for financial assistance. A few weeks later, I got a call from someone willing to give me a scholarship for \$5,000 to assist with the fees. I can finally get my baby into daycare thanks to this program's willingness to go above and beyond to assist me."
