2025 – 2026 Food Resiliency Grant Request for Proposals

INTRODUCTION

United Way of Central Maryland (United Way)'s Food Resiliency Grant is an opportunity for community-based organizations with total annual operating budgets of \$500,000 or less in their current Fiscal Year to receive up to \$10,000 per year for 2 years in funding to carry out community-centered projects that are aimed at building food resiliency in the six jurisdictions of Central Maryland: Anne Arundel County, Baltimore County, Carroll County, Harford County, Howard County, and Baltimore City. This initiative recognizes a critical need to build the resiliency of food production sites and increase access to healthy and affordable food in underserved areas.

A total of six community partners will be selected, one for each of the 6 jurisdictions in Central Maryland that United Way serves. The two-year grant period will be **January 1, 2025** – **December 31, 2026,** with grant disbursal occurring in January 2025, year 1 and January 2026, year 2. Funding in year 2 is contingent upon satisfactory year 1 progress. Applications must be submitted through our online grant application portal, CommunityForce. The application portal as well as all application materials can be accessed through our <u>Grants and Funding</u> Opportunities page.

GENERAL APPLICATION INFORMATION

Central Maryland faces significant challenges related to food access, equity, and sustainability. Many communities experience limited access to fresh, healthy, and culturally appropriate food, contributing to health disparities and food insecurity. Additionally, our current food system is vulnerable to disruptions, such as natural disasters, economic shocks, and climate change. This is the first year of United Way's Food Resiliency Grant opportunity – which focuses on amplifying the power of communities to meet the critical nutritional needs of residents so that they may live healthier and happier lives.

United Way promotes equity, creates opportunity, and improves lives. Our 99 years of service to the people of Central Maryland have taught us what it takes to change our region for the better. We are proud to be a source of support, compassion, and hope for people who work

hard but still cannot make ends meet. We strengthen families and communities by taking on systemic challenges and increasing access to basic needs—health, housing, employment, education, and more.

United Way's grantmaking supports programs and initiatives in Baltimore City and Anne Arundel, Baltimore, Carroll, Harford, and Howard counties. We have come to believe that the true path to real, lasting, and systemic change in our communities is one that is communityled, informed by their in-depth knowledge of existing assets and needs, and inspired by their desire for a healthier, happier community.

ELIGIBILITY

United Way will accept applications from organizations with **501(c)(3) or other nonprofit IRS designations**, with a total annual operating budget of **\$500,000 or less** in their current fiscal year. United Way will also accept applications from organizations that do not have nonprofit status but are utilizing a Fiscal Agent/Sponsor that does.

Additionally:

 Organizations that currently receive other funding from United Way are also eligible to apply.

All organizations seeking funding must:

- Provide evidence that they hold a current "Good Standing Certificate of Status" with the State of Maryland Department of Assessments & Taxation.
- Provide Determination Letter from the IRS.
- Provide a copy (within the last two fiscal years) of one of the following financial documents, based on your annual gross income from charitable contributions from that year. Organizations using a fiscal agent/sponsor must provide this required financial document for their fiscal agent/sponsor.

SUBMISSION

Organizations may submit a maximum of **one application**. Multiple applications submitted by an agency <u>will not</u> be reviewed.

The deadline for application submission is **Thursday**, **September 12**, **2024**, **4:00** p.m. **EDT**. Only complete applications will be considered for funding.

INELIGIBLE ACTIVITES

United Way <u>will not</u> provide funding to organizations that discriminate with regard to race, color, religion, national origin, gender, sexual orientation, gender identity / expression, age, ancestry, marital status, or disability. In addition, applications requesting support for the following <u>will not</u> be considered:

- Religious activities (religious organizations may apply for funding for non-sectarian activities)
- Lobbying activities
- Individuals applying on their own behalf.
- Compensation (salary and/or stipend) to individuals under the age of 14. Please note that organizations compensating individuals 14-17 years old must do so within Maryland State Labor Department guidelines.

PROJECT CATEGORIES

Projects should primarily fit into one of the two categories listed below. With these two broad project categories, United Way hopes to allow flexibility for organizations to tackle projects that can have an impact in their specific community. We have included a few examples for each category, but other projects are welcome.

We ask applicants to identify a primary project category, however, projects may address both categories.

1. Building Resiliency of Food Production Sites: Address the causes and systemic challenges within the food supply system that prevent it from being resilient, equitable, and sustainable by directing your work towards the source of food. This approach focuses on improving the foundational elements of food production, processing, and distribution.

Examples: sustainable agriculture projects, local food procurement, food hubs and aggregation, value-added processing, food system mapping and local data collection, building capacity of organizational leadership and infrastructure

2. Increasing Food Access in Underserved Areas: Implement strategies and initiatives that ensure all individuals and communities, regardless of their socioeconomic status or neighborhood, have the opportunity to obtain food options at a price they can afford.

Examples: community gardens, mobile markets, grocery co-ops, healthy corner store initiatives, SNAP/EBT incentives, nutrition education and cooking classes, food recovery and redistribution

APPLICATION SELECTION CRITERIA

All eligible applications will be reviewed. Applications will be evaluated on how well they align with at least one of the two Project Categories listed above and the degree to which they effectively address the **criteria** listed below.

- 1. **Engage communities:** Empower residents to participate in shaping their local food systems through education, outreach, and advocacy efforts.
- 2. Advance upstream solutions to food insecurity: Focus on prevention of root causes rather than symptoms through long-term innovative solutions that prevent food insecurity from occurring in the first place by tackling the underlying factors that contribute to it.
- 3. Show promise of positive impact in the following areas:
 - Promote sustainable practices: Encourage environmentally responsible food production, distribution, and consumption practices that conserve resources, reduce waste, and mitigate the impacts of the project's footprint.
 - Expand the availability and affordability of nutritious food through initiatives that reduce barriers to acquiring healthy and culturally relevant food.

In addition to meeting the criteria established above, successful applications will:

- ✓ Be complete, following all application instructions.
- ✓ Demonstrate that the applicant will conduct a project aligned with at least one of the two established categories.

Additional Selection Priorities

While not required, priority will be given to applicant organizations that are led by Black, Indigenous, or People of Color (BIPOC), or people from marginalized communities / hard to reach populations.

For Baltimore City Applicants: Priority will be given to proposals that target communities and/or populations residing in or near Healthy Food Priority Areas (HFPAs) as defined by the Baltimore City Department of Planning Healthy Food Environment Strategy.
